

REDI-HEAT-4 DIGITAL THERMOSTAT RDT-4

- > Your new RDT-4 Thermostat can control 4 heat mats up to 15 total amps or 1800 watts.
- The RDT-4 Thermostat is 120VAC ONLY.
- > The RDT-4 will keep your temperature setting within +/-1 degree.
- > Do not expose RDT-4 Thermostat to direct water.
- > Plug the RDT-4 into a GFCI outlet to prevent shocks.
- Use the UP/DOWN buttons to set your desired temperature
- > The dual 7-segment display only shows your set point, NOT THE CURRENT TEMPERATURE.
- > To view current temperature, press both the up and the down button at the same time.
- To monitor your growing media's temperature, place the RDT-4's temperature sensor into the plant substrate to desired depth that you wish to control temperature (sensor position/orientation is not important.
- Do not place the sensor directly on the mat. Soil temperature cannot be maintained properly in this location.
- The red LED will be lighted only when sending power to your heat mats/cables, when LED is off then no power is at the heat mats/cable and therefore not heating and your soil is at the set temperature.
- Since soil temperature will be constantly maintained at a higher level, soil media and plants will dry more quickly and require more frequent watering.
- > A consistent amount of soil moisture will maintain the most even heat.
- If the soil dries out, the sensor will not be able to detect the heat from the mats or cables, due to soil being a good insulator. It is the water in soil that moves heat.

If you are having trouble finding a place to mount your RDT-4 Thermostat Phytotronics has bench plates available for purchase.

Troubleshooting tips:

- If the display is not lit, check for power at the outlet the RDT-4 is plugged into and check the fuse located in the middle of the outlets. No power at the outlet could mean a tripped GFCI and/or circuit breaker. A blown fuse means too much power or a short. Replace fuse and test each mat by plugging them in individually until you find the one responsible for the short.
- > To figure amps, divide the total wattage of the mats or cables being used by 120.
